# TOGETHER; creating a better environment where we work to better serve our clients

We would like to again take this opportunity to inform all operators within the Central Business District that clusters of CCTV cameras which are being monitored by LESA, have been installed in **Triq I-Esportaturi, Triq San Gwakkin**

**and Triq is-Salib ta' I-Imriehel.** Whilst the primary objective of these cameras is to serve as a deterrent for illegal dumping of waste, traffic violations are also being surveyed. Another 3 clusters of CCTV cameras will be installed

in a further 3 locations later this year, to continue to assist in our fight against illegal dumping. The problem of illegal dumping of waste not only creates an eyesore in the area but is also a health hazard contributing to potential infestations. In this respect, you are kindly being referred to the attached leaflet which was distributed last year regarding the National new waste regulations and collections introduced in 2023.

All operators are reminded that daily waste collection commences at approximately 3pm and that the regulations clearly state that waste cannot be taken out more than 4 hours before collection and definitely not after it has been collected.
